**Subject: Commission proposal for a Compliance Support Facility** 

Dear Mr Ladefoged,

The undersigned associations, representing European manufacturing sectors within the scope of Ecodesign and Energy Labelling, support the EU Ecodesign and Energy Labelling Framework. These tools have delivered considerable energy savings across Europe and have led to higher efficiency products for European consumers. Further advancements in the benefits for consumers cannot be achieved without compliance and appropriate market surveillance and enforcement, and it is therefore indispensable that further advancements are made in those fields.

It is evident for the undersigned associations that market surveillance, enforcement, and compliance deserve more attention and resources in order to fully utilise the potential of the Ecodesign and energy acquis and to ensure that manufacturers operate on a level playing field in the EU market. Nonetheless, we have concerns with the Commission proposal for a Compliance Support Facility, about which we have been informed through partner industry associations.

With this letter, we would like to support the message that you have received from APPLIA, EHI, Eurovent, and LightingEurope on 28 January 2022. Although we appreciate the Commission's efforts to improve compliance with Ecodesign and Energy Labelling rules, the undersigned associations do not believe that the current proposal is appropriate for the objectives it intends to achieve.

Our concerns are centred around the following aspects:

- The Compliance Support Facility envisages that private industry associations, on behalf of the Commission, will have to provide interpretation on rules on which they have a vested interest.
- The Compliance Support Facility is also envisaged to develop interpretation and answers to questions in alignment with all the participants to the Compliance Support Facility. As the topics raised can be highly complex and have a competitively sensitive nature, it may be difficult to agree within the Facility and it may also not be appropriate for the group members to deal with certain types of information and questions.
- Industry associations, but also consumer organisations and NGOs, do not have the legal structure
  and are not entitled to carry the liability that flows from the proposed Compliance Support
  Facility. We strongly believe that industry associations can make FAQs and guidelines for their
  own membership or specific industry, but that it is the Commission who should provide such
  tools for the whole market within the scope of Ecodesign and Energy Labelling.

We recommend the Commission to refrain from moving forward with this initiative. Compliance, market surveillance, and enforcement are important subjects that need to be addressed and improved, and we are available to discuss alternative initiatives on how to move forward.
